Presidents Column Fred — W2EMS

The world above (or below, depending on how you look at it) 6 Meters.

I have a Paramedic friend I worked with several years ago, John Lennon, (no... not the singer). John and I worked at the same commercial ambulance service in Schenectady for several years and worked together many occasions.

I was saddened to hear that John was leaving the Capital District and head to Bar Harbor, Maine to advance his career as a Paramedic and not soon after continue on as a Paramedic/Fighter in the Village of Bar Harbor. John is doing very well in Maine and he frequently sends me photos and news stories about dramatic news happenings in and around his home.

John has been a Ham since about 1998 holding a Tech Plus license but John's grandfather, Donald Bulger (WB2VJC) pushed and pushed for "little" John to upgrade to General to allow more frequent conversations on HF. Well, to make a long story short, John passed the General written test and aced the code test (he should have since he was a Radioman in the Coast Guard for years).

Don sent John a few boxes of "gear" and before you knew it John was on the air and we were having weekly QSO's between John, (KB1DRS), his grandfather Don, (WB2VJC), John's uncle Dennis, (N2USN), and myself. We have a great time when we can find an open spot on the 80 meters.

Since John received his General license it really opened opportunities to a wide range of bands to choose from and allows us to "work" each other whether we're a few miles apart or 300+ miles away.

Although I've never worked any long distance stations,

I know from talking to other hams that if you want to talk to hams in the next State, across the country, or around the world; HF is the way to go and upgrading to a General class license is the way to do it.

Consider upgrading before the General class (Element 3) test question pool changes take effect in 2007. The new questions will be released December 1, 2006, and become effective July 1, 2007 so you have about eight months to pass the Element 3 exam before the questions change. There are many ways to help you study for the exam to include ARRL question and answer books, interactive CD Rom's, and even Web based training. The entire question pool can even be downloaded free of charge from the ARRL web site.

If you have a radio capable of tuning into the HF bands there are many simple and inexpensive antennas that you can make to get on the air the very same day you pass your test. And don't forget to ask for help from a fellow ham or find an "elmer" to get you started.

Radio Officer's Report:

- Simulated Emergency Test on 10/1/06 was run successfully, and 16 participants have been added to the ARES/RACES Yahoo group. Others may visit this site (www.groups.yahoo.com/group/Saratoga_Co_ARES_RACES/) to register for emails and other plans and protocols to be used in case of emergency.
- Advanced Skyward training is coming up for those interested in fine-tuning their skills. Contact Dave for details (datwell@nycap.rr.com)
- The new DB-224 antenna for the .36 repeater is up and working well. A new controller with PL tone will be installed soon. The repeater has a weather alert that is triggered by threatening weather from the West. Be advised, this alert may trigger at any time – even in the middle of your transmission.

Jim's Report (K2LM)

- Jim has suggested changing the .00 repeater PL tone to 91.5 Hz, because of interference from a NH machine using the current 100Hz tone. The .24 repeater should use same tone for consistency. The board voted to approve these changes at some time in the future. Members will be given ample notice before this occurs .
- Jim also explained that the .00 repeater antenna will have to move soon from its current location on a county tower on Spruce Mountain in Corinth. The county is negotiating with National Grid to move its antennas to the nearby NG tower, and remove its towers from the peak inside the Adirondack Park. This switch will necessitate our buying a new repeater antenna, because the riggers hired by NG will only handle commercial-grade equipment.

Thus, the board voted to authorize the expenditure of up to \$1500 for a new antenna and associated hardware in preparation for the move

General Membership Meeting Minutes(abbreviated)

Meeting called to order at 7:30PM by President.

- Membership was asked to consider and vote on changes to the group's Constitution & Bylaws, proposed by the board. The significant changes include (among minor details):

-Filing of an "assumed name" with the county to simplify and clarify our identity. The name will be *Saratoga County Amateur Radio Association*. This will not change the formal, legal name of the organization.

-Adoption of annual Board of Directors *Directives* report to membership, outlining major goals for each coming year

-Removal of the quorum requirement of 10% of voting membership for actions at the general meeting, since we rarely have that many attendees and membership is a constantly changing figure.

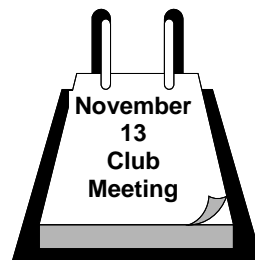
After some discussion, the changes were voted on and passed unanimously by the members in attendance.

Editor's Corner

It has been brought to my attention that the FCC has made some important decisions that affect all hams:

II. EXECUTIVE SUMMARY

In this R&O, we amend the Part 97 Amateur Radio Service rules as follows:

- Revise the operating privileges of amateur radio operators to allow more spectrum in four currently-authorized amateur service HF bands to be used for voice communications;
- Permit auxiliary stations to transmit on additional amateur service bands;
- Permit amateur stations to transmit spread spectrum communications on the 1.25 meter (m) band;
- Permit amateur stations to retransmit communications from the International Space Station;
- Permit amateur service licensees to designate the amateur radio club to receive their call sign in memoriam;
- Prohibit an applicant from filing more than one application for a specific vanity call sign;
- Eliminate certain restrictions on equipment manufacturers that are no longer necessary;
- Permit amateur radio stations operating in Alaska and surrounding waters more flexibility in providing emergency communications; and
- Remove certain restrictions in the amateur service license examination system that are no longer necessary.

Also a new law formally makes Amateur Radio part of Emergency Communications Community.

A section of the Department of Homeland Security (DHS) 2007 Appropriations Act, HR 5441 <<http://thomas.loc.gov/cgi-bin/bdquery/z?d109:h.r.05441:>>, formally includes Amateur Radio operators as a part of the emergency communications community. Congress approved the measure before adjourning for its pre-election break. President George W. Bush signed the bill into law October 4.

Amateur Radio is included within the legislation's Subtitle D, Section 671, known as the "21st Century Emergency Communications Act." Radio amateurs are among the entities with which a Regional Emergency Communications Coordination Working Group (RECC

Working Group) must coordinate its activities. Included within the DHS's Office of Emergency Communications -- which the measure also creates -- RECC Working Groups attached to each regional DHS office will advise federal and state homeland security officials. The final version of the legislation incorporated language from both House and Senate bills and was hammered out in a conference committee.

In light of the new legislation, the ARRL plans to follow up to determine how it can interact with the DHS and its Office of Emergency Communications.

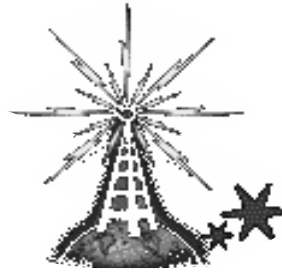
